The Levi Garrett Racing Team is gearing up for a run at the 1989 Winston Cup Championship. An unprecedented mid-year model switch (from the Monte Carlo to the Lumina) is scheduled for all Chevrolet teams after the eighth event of the season.

1988 SEASON REPORT — THE NASCAR YEARBOOK AND PRESS GUIDE

At the conclusion of the 1988 Winston Cup Racing season, Geoff and the Levi Garrett Racing Team ranked sixth in the Winston Cup Point standings with 3799 accumulated points. They scored one win, ten top five finishes, sixteen top ten finishes and three Busch Poles. Geoff finished fourth in True Value Hard Charger Points and Waddell Wilson finished fourth in TRW Mechanic Points.
